# Key Responsibilities, Knowledge and Skills

#### **Responsibilities**

The responsibilities of the role outlined in this job description are indicative of the currently envisaged scope and may be added to or altered as required, in line with the requirement of SEAI across Business Units/Department.

They will include, but not limited to, the following:

- Analysing and presenting key financial and non-financial data and advising senior management on outputs. Understanding trends, correlations, and policy implications.
- Playing a key role in the upgrading and/or development of a new financial system and ensuring the system is operated to its full potential and fit for purpose.
- Working closely with the IT Department and Programme Managers in the development of new programmatic systems in identifying areas of alignment to financial systems.
- Lead and co-ordinate relevant staff training on financial system.
- Lead the governance oversight of European Regional Development Funds, ensuring processes are in place, claims are processed on a timely basis and compliance can be demonstrated during Departmental and European audits.
- Critical review and sign off, of all Grant Payments, ensuring internal controls are adequately designed and operating effectively.
- Documentation of methodology used in developing KPI's and regular update of same.
- Ongoing review of procedures and policies ensuring all are up to date.
- Co-ordination of financial PQ's and FOI's.
- Preparing and presenting reports to Executive Leadership Team, Audit and Risk Committee and Board.
- Work closely with the Financial Controller in the completion of monthly Business Partnering with Programme Teams.
- Managing and developing staff within the Finance Department.
- Work closely with the Financial Controller in promoting a strong governance system across all areas.
- Providing Finance input into large scale procurement activities.
- Input into Internal and External Audit and Annual Financial Statements preparation.
- Project managing different projects or assignments and liaising with relevant stakeholders to ensure collaborative solutions are developed and implemented successfully.

To ensure that activity peaks within the Department are addressed in a proactive manner, it is expected that the candidate appointed to this role will need to be flexible in terms of working hours during these periods.

Tenure:	This position will be offered on a 5-year Fixed Term contract basis.
Salary Payment Arrangements:	The Level E salary scale for this position effective from 1 <sup>st</sup> June 2024 is as follows: €78,303 to €102,085 (inclusive of two Long Service Increment (LSI1) which applies after three and after 6 years additional service at Max of grade). Incremental progression will be subject to satisfactory performance.

Location:	The place of work will be based at one of the SEAI offices as listed on cover page. SEAI offer the option to work in a hybrid working arrangement, in line with the SEAI Blended Working Policy. SEAI reserves the right, at its discretion, to change working location within reason on any future date.
Blended Working Arrangements:	As an employer, SEAI operates a blended working policy that facilitates access to remote working options having regard to work-life balance/integration, mental health, and the need for a safe and productive working environment. Blended working arrangements will be operated under SEAI's Blended Working Policy, which currently requires staff to work from the office a minimum of two (2) days per week.
