## Company & installer registration

We do not require an applicant to select a company from a register. This allows you to use your preferred company to complete the works and allows more of the supply chain to participate in the scheme.

However, in order to monitor quality within the supply chain for the scheme we do require that all companies and their associated installers carry out a registration process the first time they are nominated under the scheme. This is a simple process and they do not have to be registered to commence the works but rather before you make an application for payment.

Please note as part of the registration they can decide whether they wish to be on the published register of companies and installers or not. If they opt out of this list, they will remain in the application portal in case they want certain clients to select them on future applications.

It is important that prior to commencing the works both your nominated Company/Contractor and their associated Installer download the registration forms for their respective roles and satisfy themselves they can comply with all Terms and Conditions outlined therein.

Your grant cannot be paid if these requirements are not met.
