Note: New source for Electricity and Gas Prices from October 2010: Due to full deregulation of the market, prices are now sourced from the prices gathered for the EU Gas & Electricity Price Transparency Directive. Electricity - from 01/10/2019 the Public Service Obligation (PSO) levy was decreased as follows: From €11.97 to €10.35 per customer per month for small commercial customers (max import capacity < 30kVA) and from €1.32 to €1.22 per kVa for medium and large customers (max import capacity >= 30kVA). Carbon Tax was introduced for Oil, L.P.G and Natural Gas on 1st May 2010. The Carbon Tax was extended to Coal and Peat on 1 May 2013. See www.revenue.ie for more details.

- 13. If a night rate electricity meter is installed and if the heat pumps are run during the night, a unit cost of approximately half that specified can be assumed in the calculations for heat pump running costs.
- 14. Seasonal Performance Factor is defined as the ratio of heat output from the heat pump and the electricity supplied to the heat pump over the heating season. SPFs quoted assume heat pumps are used in conjunction with low temperature systems such as underfloor heating.
- 15. The Home Heating Appliance Register of Performance (HARP) database contains exact performance specifications of the proposed/installed appliances. www.seai.ie/harp While HARP is not used in non-domestic Building Energy Rating (BER) it still gives a useful indicator of appliance efficiency/SPF for the purpose of commercial fuel cost comparisons.
